Dear Senator Darling and Representative Nygren:

In accordance with Wis. Stat. § 51.06 (8), the Department of Health Services (DHS) is providing a Report on Relocations and Diversions from Institutions. This year's report submission includes reporting for State Fiscal Year (SFY) 2018 and SFY 2017.

The DHS relocation and diversion programs have been successful, providing the opportunity for elderly individuals and people with physical and developmental disabilities to live in community-based settings, who otherwise would have resided in ICFs-IID and nursing facilities. Relocated individuals historically participated in one of the DHS Medicaid Home and Community-Based Waiver Programs. These programs included the ICF-MR Restructuring Initiative, the Community Integration Program (CIP) 1A, the Community Relocation Initiative, and the Nursing Home Diversion Initiative. As of June 2018, CIP and the Community Options Program Waiver (COP-W) were phased out and fully transitioned into the Family Care and Include, Respect, I Self-Direct (IRIS) waiver programs. Family Care and IRIS offer community or institutional long term care services to all eligible consumers based on their preferences and needs. As a result, the enclosed reports reflect the movement away from the legacy waiver programs, resulting in a reduction in relocations and diversions between SFY17 and SFY18. This trend is expected to continue in light of these extensive programmatic changes.

COMBINED SFY 2018 and SFY 2017 REPORT on RELOCATIONS and DIVERSIONS from INSTITUTIONS As required by Wis. Stat. § 51.06 (8)

The Department of Health Services (DHS) has been providing elders and people with physical and developmental disabilities residing in nursing facilities and intermediate care facilities for individuals with intellectual disabilities (ICFs-IID) the opportunity to relocate to community-based settings through three program initiatives. DHS also provides support to a limited number of people who are at imminent risk of entering a nursing home to be diverted from a nursing home admission and remain in their community.

The DHS relocation and diversion programs have been highly successful over the years, providing the opportunity in state fiscal year (SFY) 2018 for 248 elderly people and people with physical and developmental disabilities to live in community settings, closer to family and friends and community activities. As shown in the summary table below, 174 (70.16%) relocations and diversions were for frail elders; 65 (26.21%) were for people with physical disabilities; 9 (3.63%) were for people with developmental disabilities.

In SFY 2017, there were a total of 381 elderly people and people with physical and developmental disabilities: 267 (70.08%) relocations and diversions were for frail elders; 101 (26.51%) were for people with physical disabilities; 13 (3.41%) were for people with developmental disabilities.

This report provides information consistent with prior year reports, but the movement from the legacy waiver programs (Community Options Program and Community Integration Program [CIP]) has significantly altered the way people transition from institutional settings to the community. While in Family Care, a person can enter a nursing home when necessary due to health conditions and remain enrolled in Family Care. These transitions that occur within the Family Care program do not meet the definition for transitions used in this report and are not reflected in this data. As Family Care continues to expand, use of traditional relocation and diversion measures has become somewhat outdated.

Since SFY 2006, 7,211 elders and people with physical and developmental disabilities have successfully relocated from institutional settings and an additional 1,533 people were diverted from admission to a nursing home through DHS programs. The quality of life for these 8,744 people has been enhanced through the opportunity to live in the community and be near family and friends and more fully engaged in community activities.

^{*}DHS does not operate a specific diversion initiative for people with developmental disabilities, but new placements into institutions are limited and new people are enrolled in home and community-based programs each year on a regular basis, essentially diverting them from institutional care.

Highlights of the relocation and diversions initiatives over the past 13 years (SFY 2006-2018) include:

- 988 people with developmental disabilities, many of whom resided in institutions for decades, moved to the community and participated in community activities that were not available to them when they resided in institutions.
- 4,286 frail elders who resided in nursing facilities chose to live in the community near their families and friends. Prior to this initiative, these people would have been on a waiting list

for Medicaid home and community-based services waiver care and few would have had the opportunity to return to the community.

- 1,937 people with physical disabilities chose to live in the community where they are able to access community activities rather than live in nursing facilities.
- People are being served in the community at a cost below that of institutional care, resulting in savings to the medical assistance programs in SFY 2018 of \$910,000 for the people relocated during the year.
- 1,162 elders and 371 people with physical disabilities, who were determined to be at imminent risk of having to move to a nursing facility, were able to remain in community-based settings because diversion funding was made available.

In 2007, DHS was awarded a federal "Money Follows the Person" (MFP) grant to support rebalancing of the long-term care system through further relocations from institutions to the community. Starting October 2007 and continuing until service dollars are exhausted, the federal government pays a match rate that is higher than the standard Medicaid matching rate for the costs of certain relocated people during their first 365 days in the community. There were 227 brand new participants in MFP in SFY18, and 415 individuals participated at any point in time over the course of the year.

Relocation Initiatives

DHS provides elders and people with physical and developmental disabilities residing in nursing facilities and ICFs-IID the opportunity to relocate to community-based living arrangements under the following three programs:

- ICF-IID Restructuring Initiative
- CIP 1A
- Community Relocation Initiative (CRI)

Although the funding mechanisms for these programs were established under the legacy CIP and Community Options Program waivers, persons who relocated from institutions to Family Care, Family Care Partnership, and PACE are included in the ICF-IID Restructuring Initiative, CIP 1A, and CRI numbers.

ICF-IID Restructuring Initiative

The ICF-IID Restructuring Initiative serves persons with developmental disabilities receiving active treatment in a non-state-owned ICF-IID or a non-state-owned nursing facility. (Relocations from the three state centers for people with intellectual disabilities are part of the CIP 1A described below.) The initiative was authorized in the 2003-05 biennial budget bill and became effective on January 1, 2005. Under the initiative, counties are required to prepare a community plan for every person residing in an ICF-IID and for every person seeking admission to an ICF-IID. The plan must be submitted to the court and the court must consider the plan, along with other information presented to the court. If the court determines that the community is the most integrated setting appropriate to the needs of the individual, then the court must order the person to be served in the community. If the person with a developmental disability was a resident of an ICF-IID or a nursing facility, then the initiative allows money that was previously used to fund their institutional care to follow the person into the community to fund community-

based care. Funding can also be used under this initiative for community placements for people relocated from facilities that are closing or downsizing. Under this initiative, the entire cost of the person's care plan is funded by state and federal funding. Therefore, no county tax levy funding has been required to fund these relocations.

In SFY 2018, two people (9 in 2017) with developmental disabilities moved into the community from non-state-owned ICFs-IID and nursing facilities as part of this initiative. In their new community settings, these people had their care needs fully met and participated in community activities that were not available to them when they resided in institutions.

As a result of the ICF-IID Restructuring Initiative and other factors, the long-term care system for people with developmental disabilities has been significantly rebalanced towards community settings. Since the start of this initiative in January 2005 through SFY 2018, a total of 947 people transitioned to community settings. In June of 2018, only 70 people were living in the four remaining ICFs-IID excluding the state centers. Twenty-eight ICFs-IID have closed over the course of the initiative.

CIP 1A

CIP 1A, which began in 1981, supports relocations of people with developmental disabilities from the long-term care programs in the three state centers for people with intellectual disabilities to homes in the community. As established in the 09-11 biennial budget, effective SFY 2010, DHS adopted a universal budgeting methodology that eliminates an upper limit on daily costs (formerly \$325) and provides the full funding needed in the community for each relocated resident. In SFY 2018, there were no individuals relocated from a long-term care program in a state center to the community.

CRI

CRI provides elders and persons with physical disabilities residing in nursing homes the opportunity to relocate to community settings. People being cared for in nursing homes have a choice to remain in their current setting, or move to the community when their care needs can be met at home, in an apartment, or in an assisted living setting. The funding being used for a person's institutional care "follows" the person into the community to be used in the Medicaid home and community-based services waiver. CRI was authorized in the 05-07 biennial budget bill and began in August 2006. In SFY 2018, a total of 282 people relocated from nursing homes under CRI. Of the 282, 180 were elders and 93 were people with physical disabilities. In SFY 2017, a total of 415 people relocated from nursing homes under CRI. Of the 415, 250 were elders and 152 were people with physical disabilities. These people chose to live in the community where they could be closer to family and friends and more fully access community activities.

Diversions

Nursing Home Diversion Program

The Nursing Home Diversion Program provides support to people who are at imminent risk of entering a nursing home to be diverted from nursing home admission and remain in community settings. The program was authorized in 2005 Wisconsin Act 355 and began in April 2006. Participants in this program are served under the CIP II Medicaid home and community-based services waiver. To be eligible for these diversion funds, a person is required to meet certain risk criteria as defined by DHS, as well as meeting the Medicaid functional and financial eligibility criteria for CIP II. The statute originally authorized DHS to provide an enhanced CIP II rate for up to 150 people who are diverted from imminent entry into a nursing home and to provide diversion opportunities for additional people, subject to the concurrence of the legislature. Subsequent to the original legislation, the legislature passed and the governor approved 2009 Wisconsin Act 277. This act, which became effective in May 2011, removed the limitation on

the number of CIP II nursing home diversion slots available to be used by counties to divert high-risk elders and persons with physical disabilities from entering nursing homes.

To be eligible for diversion funding, an individual must meet all of the following criteria:

- Belong to a target group served by CIP II (elderly age 65 or older and/or have a physical disability).
- Be functionally and financially eligible for the CIP II program.
- Reside or intend to reside in a community setting that is eligible for CIP II.
- Meet high-risk criteria for imminent entry into a nursing home.
- The costs of the person's Medicaid-funded community care plan must be no greater than the Medicaid costs the person would have incurred in the nursing home.

As a part of the diversion initiative, DHS was required to develop and utilize criteria to determine who is at imminent risk of entry into a nursing home. In developing the criteria, DHS reviewed national studies, analyzed Wisconsin data, and consulted with county long-term support coordinators and staff. Factors that are considered in the criteria include:

- Meeting an intensive skilled nursing (ISN) level of care.
- Facing an imminent loss of current living arrangement.
- Having a fragile or insufficient informal caregiver arrangement.
- Having a terminal illness.
- Having multiple other factors that are associated with nursing home entry.

Under the Nursing Home Diversion Program in SFY 2018, a total of two people were diverted from nursing home admission and remained in community-based settings, staying close to family and friends and involved in the community. Of the total, both were elders. The diversion program was only available in the seven counties that still operated the CIP II waiver at any point in SFY18. The number of counties operating CIP II, and therefore eligible for diversion slots, has decreased over time due to the expansion of Family Care and IRIS. Family Care and IRIS were expanded to six additional counties in SFY 2018. Family Care and IRIS operate statewide as of July 1, 2018.

The ages of the individuals who benefited from the Nursing Home Diversion Program are shown in the chart below.

Nature of Living Arrangement

The following tables shows the living arrangement for people relocated in SFY 2018 and in SFY 2017. In 2018, 335 (89.4%) people moved to a home or apartment. The next most frequent setting was an adult family home, with 16 (5.7%) people choosing that setting.

Duration of Relocations

Of the 282 people relocated from nursing homes in SFY 2018 (415 in 2017), 14 (29 in 2017) people died and four (16 in 2017) people returned to a nursing home during the year. The

remaining people continue to live in the community and virtually all continue to receive services through Family Care, Family Care Partnership, PACE, or the CIP II Medicaid home and community-based services waiver program.

Of the two people who relocated from an ICF-IID in SFY18 (9 in 2017), no deaths occurred during the year. No individuals were relocated from long-term programs at state centers during the year. Appendix B provides information on deaths and returns to institutions among people who have moved from ICFs-IID and state centers since SFY 2006.

Costs Under the Medicaid Program

Medicaid costs were calculated for both the period when the person was in an institution and the period when the person was living in the community to determine the net Medicaid cost of the relocation programs. The analysis examined the following two components: (a) the institutional or Medicaid home and community-based services waiver costs; and (b) other Medicaid (MA) costs, termed MA Card Costs, which include the Medicaid costs for personal care services, therapeutic services, and all other MA services. This provides a comprehensive presentation of the person's Medicaid costs in each setting.

CRI

As summarized in the table below, in SFY 2018 the average daily cost in the nursing facility for people before they relocated under CRI was \$157.17 (\$150.62 in 2017). In contrast, the average daily cost in the community after relocation for these same people was \$120.17 (\$116.17 in 2017). Community relocations under the CRI were cost effective, producing an average daily savings of \$37.02 (\$34.45 in 2017), representing a 23.6% (22.9% in 2017) cost reduction.

As shown in the table below, the total MA cost in SFY 2018 of serving the 246 (350 in 2017) people who relocated to the community under CRI during the period they lived in their new community settings was approximately \$2.97 million (\$5.31 million in 2017). If these people had remained in their institutional settings during this time period instead, their MA cost of services would have been approximately \$3.88 million (\$6.9 million in 2017). Due to the difference between institutional and community costs, CRI produced total savings of more than \$810 thousand in SFY 2018 (\$1.58 million in 2017).

ICF-IID Restructuring

When implemented in 2005, the ICF-IID Restructuring Initiative established an amount of funding to be used for the costs of all people eligible for the initiative either in institutional or community settings. DHS was expected to manage the costs of serving those people remaining in institutions and the costs of new community relocations within the global ICF-IID Restructuring budget. As managed long-term care (Family Care) and IRIS have expanded to a large portion of the state, DHS has moved away from this budgeting mechanism for the ICF-IID Restructuring Initiative.

CIP 1A Program

As noted above, people with developmental disabilities relocated under the CIP 1A program are funded by the state MA program for their actual community costs. The institutional cost at the state center where they resided will be decreased by the amount of the individual care plan, making the program cost-neutral.

Nursing Home Diversion Program

The average daily community cost of people served under the nursing home diversion program in SFY 2018 was \$50.47 (\$58.67 in 2017), of which \$44.97 (\$55.19 in 2017) was waiver costs and \$5.50 (\$3.48 in 2017) was card costs. The projected daily MA cost of serving these people in a nursing home is \$142.11 (\$136.76 in 2017) based on the projected average facility cost for

non-developmentally disabled nursing home residents in SFY 2018 and estimated card services for CRI prior to relocation.

The estimated cost of the people served under the nursing home diversion program in SFY 2018 is \$30,500 AF (\$286,000 in 2017). The projected cost of serving these people in nursing homes, if they needed to enter a nursing home during the same time period, is \$86,500 AF (\$667,000 in 2017).

Impact on Health and Safety

Medicaid Home and Community-Based Services Waiver Quality Assurance

Assuring the health and safety of frail elders and people with developmental and physical disabilities is a paramount goal of DHS whether people live in an institution or in the community. All the people relocated under the programs described in this report are participants in one of the DHS Medicaid home and community-based waivers, which include Family Care, the self-directed IRIS waiver, and the traditional waivers (CIP and Community Options Program). All of these waivers operate under federally approved plans through the Centers for Medicare & Medicaid Services, which include extensive risk assessment and mitigation, as well as quality assurance and improvement protocols intended to ensure health and safety for participants.

All participants have highly individualized support and service plans that promote person-centered outcomes, informed choices, and community participation, in addition to addressing health and safety needs. Care management staff are required to have contact with participants at regular intervals, including face-to-face visits, to ensure that services and supports are being delivered as required and to address new needs that might arise. For persons relocating from institutions, a visit will occur shortly after the move to the community to assess the adequacy of the support and service plan and identify any issues that occurred after the move.

For all participants, ongoing assessments are methodically completed and updated. In Family Care, care planning is carried out by an interdisciplinary team, which includes a nurse. Many counties also employ nursing personnel as part of their care management teams under the traditional waivers. When unmet needs are identified, the care plan is modified. In addition to waiver services and supports, people also receive community health services, such as physician and dental visits, hospital care, personal care in their home, and pharmacy.

DHS requires Family Care managed care organizations, IRIS consultant agencies, and counties that administer traditional waivers to have a system to ensure waiver participants are adequately protected from physical, verbal, and sexual abuse, as well as maltreatment, neglect, financial exploitation and violation of their rights under law. DHS also requires these entities to have mechanisms for reporting incidents to DHS and effective response systems.

DHS uses state staff or contractors to monitor compliance with waiver requirements. This oversight uses a variety of sources, such as case records, satisfaction surveys, and visits with program participants.

Regulatory Oversight

The Division of Quality Assurance conducts regular on-site surveys of licensed three- to four-bed adult family homes and community-based residential facilities using state guidelines and standards. Counties and managed care organizations are responsible for ensuring high-quality services and environments for people living in smaller settings. Residential and day-service providers also have procedures that maintain each person's health and safety. They interact with each person on a constant basis, monitor medical conditions, provide structured social and environmental situations, and give sufficient supports to people with special needs.

DHS oversees these programs and service delivery systems by having staff throughout the state conduct several types of activities, including random unannounced visits, in-depth annual plan review, and ongoing dialogue with all stakeholders (including consumers and their families and guardians). DHS issues guidelines and establishes policies and procedures whenever necessary to address gaps that are identified or suspected.

Actual or suspected events

Any actual or suspected event that threatens the health or safety of an individual is investigated and reviewed by each provider and waiver agency. Waiver agencies are required to report all such instances to state quality assurance staff or contractors, who, depending on the nature and seriousness of the report, may investigate or involve others, such as police or the judicial system.

All deaths in licensed or certified settings are reported to and scrutinized by the state to identify negative trends associated with providers, counties, or the approaches that are used by the service delivery system with the intent of preventing further instances. Concerns are then shared with appropriate entities that are required to make systemic improvements or take corrective actions to create a constant cycle of improvement. Instances of abuse or neglect are remedied swiftly and access to necessary medical services is closely monitored.

Involvement of Guardians or Family Members

Counties are required to prepare a plan for home or community-based care for all people residing in ICFs-IID and nursing homes who are at a developmental disability level of care. For ICFs-IIDs other than the state centers, these plans are part of the statutorily required annual court review, known as the Watts review, to determine the most integrated setting appropriate to the person's needs. Counties involve guardians in the preparation of these plans and state law requires that the county provide a copy of the plan to the guardian prior to the Watts review.

When a person is relocated from a state center or other ICFs-IID or nursing home facility, the plan for a person's care is signed by the guardian indicating their acceptance of the plan.

Most elderly people and people with physical disabilities relocated under CRI do not have guardians. However, in cases where people do have guardians, the guardians are involved in the efforts to relocate or divert people from institutions.

For persons who are competent to make their own decisions, family members are involved to the extent preferred by the individual participant. DHS does not keep a record of family involvement in care planning for people who are competent to make their own decisions.

Staff turnover

Appendix C provides calendar year 2017 staff turnover rates for facilities for individuals with intellectual disabilities and nursing facilities. Staff turnover rates are provided for both full- and part-time staff for three professions: registered nurses (RNs), licensed practical nurses (LPNs), and nursing assistants (NAs).

The staff turnover rate was calculated by the Division of Quality Assurance based on information submitted in response to their 2017 Annual Staffing Survey. In this survey each nursing home and ICF-IID provided information about the number of full-time and part-time RNs, LPNs, and NAs hired in 2016. Each nursing home and ICF-IID also provided the total number of full-time and part-time RNs, LPNs, and NAs employed as of December 31, 2017, and their length of service. The staff turnover rate for each category was calculated by dividing the number of new employees hired in 2017 in that category (e.g., full-time RNs) by the total number of employees in that category on December 31, 2017. For example, if a nursing home hired two full-time RNs in 2016 and had eight full-time RNs as of December 31, 2017, the full-time RN turnover rate was calculated as 25%.
