Opioid and Methamphetamine Treatment Centers: 2020 Report to the Legislature

This report covers the calendar year 2019 activities of the regional opioid and methamphetamine treatment programs created under Wis. Stat. § 51.422.

A total of 939 individuals were served in 2019.

The services offered include:

- Assessment for treatment
- Abstinence-based treatment
- Medication-assisted treatment, utilizing buprenorphine and naltrexone
- Licensed, 24-hour residential care
- Outpatient counseling
- Handoffs to county-authorized or private continuing care

Medication-assisted treatment utilizing methadone was not provided.

Calendar year 2019 marked the fifth year of operation for the opioid treatment programs created under 2013 Wisconsin Act 195 and the second year that these programs provided methamphetamine treatment services under 2017 Wisconsin Act 27. Those programs are:

- HSHS St. Vincent's Hospital and Libertas Treatment Center (d.b.a. Northeast Wisconsin Heroin Opioid Prevention Education)
- Family Health Center of Marshfield, Inc. (d.b.a. HOPE Consortium)
- NorthLakes Community Clinic

Additionally, 2019 marked the second year of operation for two opioid and methamphetamine treatment centers supported by funding under 2017 Wisconsin Act 27: FHC-Ladysmith Alcohol and Drug Recovery Center and Lake Superior Community Health Center. This report provides data on the first full year of operation of these two programs.


In 2019, total grant funding in the amount of \$2,262,667 was available for the period January 1 through December 31, 2019. The programs created under 2013 Wisconsin Act 195 each received \$672,000. The Family Health Center of Marshfield, Inc., operators of FHC-Ladysmith Alcohol and Drug Recovery Center, and NorthLakes Community Clinic, which partnered with the Lake Superior Community Health Center, received \$333,333 and \$333,334, respectively, under 2017 Wisconsin Act 27.

This report provides summaries of key measures for each program related to the four goals of this initiative.

- **Goal 1:** To provide regional stabilization and residential detoxification services and treatment and support services for individuals addicted to opioids or methamphetamines in rural, high-need areas of Wisconsin. The measurement for this goal is the number of people served.
- Goal 2: To increase retention in opioid and methamphetamine treatment services, improve quality of life, and reduce relapse or return to using illicit drugs. Tools used to measure overall life satisfaction are used as a measurement of this goal.

- **Goal 3:** To reduce the number of deaths associated with opioid use in the areas served by the program. The measurement for this goal is the number of discharges from the program related to death by overdose.
- Goal 4: To reach out to women of childbearing age addicted to opioids, offer priority admission to services for pregnant women, and reduce the number of infants who are affected by opioids. The measurement for this goal is the number of pregnant women served.
